Richard Fast moved, Nick Smith seconded, to oppose Proposition C. 5 yes, 0 no, 1 abstain. Motion passed.

Richard Fast moved, Nick Smith seconded, to oppose Proposition D. 6 yes, 0 no, 0 abstain. Motion passed unanimously.

<u>Clint Griess moved, Nick Smith seconded, to oppose Proposition E. 6 yes, 0 no, 0 abstain. Motion passed unanimously.</u>

The time had reached 5pm, the scheduled time for the meeting to end, before the agenda was finished.

Nick Smith moved, Richard Fast seconded, to extend time for 15 minutes. No objection. Motion passed unanimously.

Nick Smith moved, Client Griess seconded, to recommend Republican John Dennis for Congress, District 12. There was debate. 3 yes, 1 no, 2 abstain. Motion passed. NOTE:

This motion is in violation of LPC Bylaw 9, Section 3 and LPC Bylaw 5, Section 1.

Nick Smith moved, Richard Fast seconded, to recommend Starchild for State Assembly, District 17. No objection. Motion passed unanimously.
